

Black Friday Promotion Terms

- 1. These Terms and Conditions govern the Black Friday Promotion 2021 ("Promotion").
- 2. The Promotion is organized by ClickMeeting Sp. z o. o., a corporation incorporated under the laws of the Republic of Poland, with its registered office at ul. Arkońska 6, A4, 80-387 Gdańsk, Poland ("**Company**").
- 3. The Promotion is open to Users of free ClickMeeting Accounts and to participants who neither have free nor paid ClickMeeting Accounts ("**Participant**").
- 4. The Promotion entitles the Participant to receive a lifetime discount off the standard price for the ClickMeeting Account ("**Discount**"), save as otherwise stated in Clause 8. below.
- 5. The Discount rate equals 20% off the regular price. The final value of the Discount is provided on the checkout page (before submitting an order by the Participant).
- 6. To receive the Discount the Participant must within the Promotion period, that is from November 26, 2021, 09:00 am CET until November 30, 2021, 09:00 am CET:
 - a. upgrade his/her free ClickMeeting Account to a paid Account, or
 - b. purchase a new paid ClickMeeting Account (applies to the Participant who does not have an active ClickMeeting Account),

and pay for the chosen Account either through the Account Panel or by using the order form available at: <u>https://secure.clickmeeting.com/order_account.html</u> or <u>https://clickmeeting.com/free-upgrade-</u> order. To apply the Discount the Participant should enter the "BF2021" promotion code.

- 7. The Discount cannot be combined with other ClickMeeting promotions pending or available during the Promotion period or otherwise. In addition, in some instances the Participant will not be able to benefit from this Promotion because he/she uses a discount under another promotion.
- 8. If the Participant makes change in the ClickMeeting Account as to the subscription period or subscription plan (for instance, a switch from annual to monthly subscription or downgrade) after receiving the Discount, or if the discounted Account has been deactivated by Company for non-payment or otherwise suspended, the Discount will be forfeited and will not be reinstated. If the Account is restored, the Discount will not be renewed. The Discount cannot be transferred to another individual or entity or be applied to any other paid ClickMeeting Account belonging to the Participant.
- 9. Company has the right to change or terminate the Promotion at any time for any reason.
